Standards Board Executive Board Meets October 15 Decides on Southern California Location for April 15, 2016 Meeting

During its monthly conference call, the Executive Board set Friday, April 15, 2016 as a firm date for the next full meeting of the Standards Board, and determined that the meeting would take place at a site in southern California.

During its next conference call, the Executive Board hopes to receive information from EAC staff concerning locations such as San Diego and Long Beach, and to make a final decision regarding the meeting's location.

The members were advised by its Designated Federal Officer, Chairwoman Christy McCormick, that Commissioner Matt Masterson had indicated that the Standards Board will have substantive business to conduct at that meeting as a result of the ongoing work of the TGDC. The meeting agenda will also include consideration of Bylaws amendments and an election to fill an Executive Board vacancy.

The Executive Board was also informed that the Council of State Governments (CSG) and the Federal Voting Assistance Program (FVAP) had created a working group to begin review of Section B of the EAVS Survey, which contains questions related to military and overseas voters. The Standards Board's own EAVS Committee (Sandy Wesolowski, Chair; Gary Poser and Lynn Bailey) will plan to work with CSG and FVAP to consider revisions to the post-2018 version of the Survey. The Board was advised that CSG and FVAP are particularly interested in participation by local election administrators in this part of the EAVS review. Any Standards Board member is encouraged to contact our EAVS Committee members if you are interested this project.

VVSG Committee Meets; Discusses TGDC and VVSG 1.1 Working Groups

The monthly conference call of the Standards Board VVSG Committee took place on October 19. Committee members received an update from Bob Giles and Paul Lux regarding the TGDC. The next TGDC meeting is now scheduled for early February 2016 (rather than December 2015).

Bob noted that NIST had announced the creation of NIST-EAC Public Working Groups designated as "Election Cycle Groups for the development of VVSG requirements" and "Constituency Groups for informing the election cycle groups". The Election Cycle Groups will focus on Pre-Election, Election, and Post-Election requirements. The Constituency Groups will address Cyber Security; Human Factors including Accessibility and Usability; Interoperability; and Testing & Certification. Bob indicated that the Election Cycle Working Groups planned to create a TWiki page, open to election officials and the general public, to facilitate discussion of the requirements. He also reported that although the Public Working Groups had not yet conducted meetings, work to organize them was underway. Bob explained that the Constituency Groups were designed to provide input to the work of the Election Cycle Groups regarding VVSG requirements.

The VVSG Committee discussed its own Working Groups, and considered how these Groups might interact with the NIST-EAC Working Groups. Paul reported that Brandon Johnson (State SD) was now employed in the private sector, and that as a result, the TGDC Liaison post was vacant. Robert Dezmelyk noted that the Usability and Accessibility Working Group had a similar scope as the NIST-EAC Human Factors, while A.J. Starling indicated that the Security Working Group would address some issues likely to be considered by the NIST-EAC Cyber Security Group. Members discussed how the work of the Verifiability/Auditability/Software Independence Working Group related to the NIST-EAC Testing & Certification Working Group.

Paul reported that he was preparing a letter to Dr. May of NIST regarding the VVSG Working Groups, and would send out a final draft to VVSG Committee members.
