INTRODUCTION

The Institute for Fair Elections is a 501.C3 organization that audits counties and states to determine Election Management System compliance with the Help America Act and the National Voter Registration Act maintenance mandates.

The data that is mined to produce information is the voter history, the birthdate and other substantive information provided by the registrant. From these sources we determine the quality of management and the present state of the election records. The results are provided to county registrars and Secretaries of State to guide them in additional cleaning that is needed. After corrections have been made, we conduct a second audit to determine what measure of improvement has been accomplished.

We look at the following:

- how many registrants did not vote for at least the past two federal, general elections or any elections in between and should be sent a Residency Confirmation notice.
- how many registrants should have been sent a Residency Confirmation Notice in years past but were not sent one.
- whether or not there are any duplicate registrations
- registrations that lack substantive information, such as a birthdate
- registrations at improper domiciles, such as commercial or government buildings, parks or vacant land.
- an abnormal amount of persons registered at a single domicile (15 registrants at a 1 bedroom, 1 bathroom house)

The registrations are also compared to the U.S. Post Office National Change of Address list to determine which registrants have moved within the previous two years.

We accomplished a cleaning of over 140,000 records in San Bernardino County by auditing their records and teaching new methods for finding duplicate registrations and other abnormalities. We then audited the State of California and made our audits available to each county. Besides San Bernardino, those counties that have benefited the most have been Orange, Riverside and Ventura.

We have expanded our audits to other states based on data availability and cost; they include Florida, Connecticut, Delaware, Idaho, Ohio, Pennsylvania, Rhode Island and Washington.

Our objective is to help California and other states clean their lists. We are currently seeking funding to help more states to realize and develop effective maintenance techniques outlined in HAVA and the NVRA.

EXECUTIVE SUMMARY

The Institute for Fair Elections studied the state's of California, Connecticut, Florida, Idaho, Ohio, Pennsylvania and Washington. Los Angeles County, California had the highest propensity of registrants who had not voted for a period of two or more federal, general elections. This year California was able to bring all of its counties online through VoteCal, so that they may now communicate and update registrations more efficiently.

Florida had the greatest number of persons registered whose birthdays indicated that they were over 105 years old. Since accurate birthdays are mandated by the NVRA, these registrations are not valid and may only vote by a provisional ballot.

All of the states showed high numbers of registrations wherein the person had not voted for over two years. Each state had duplicate registrations and registrants who had voted more than once in an election.

PROVIDING RESOURCES TO COUNTY REGISTRARS

1. We work with registrars to make certain they send Residency Confirmation Mailings (mandated by law) to everyone registered.

Those who have not voted in or between the past 2 federal, general elections and did not respond to the card must be removed from the active list and placed in the inactive file.

2. We sort registrants by field variables to discover who is registered more than once.

Lists of duplicate registrations are given to the registrars to eliminate. Lists of those casting duplicate votes are given to the county district attorneys and reported to county supervisors.

3. We review Social Security records and cemetery indexes

4. We are developing a fix for this using the Public Records Act.

5. We use public document requests to get numbers from Juror Services and find those who responded to a juror summons stating that they cannot serve as they are not citizens.

The Institute for Fair Elections recently worked with the San Bernardino County Registrar of Voters in California to eliminate over 100,000 voter registrations. These registrations did not meet the standards set forth by the Help America Vote Act. The registrations eliminated were people who were voting:

- more than once
- for deceased registrants
- from fraudulent addresses
- from commercial addresses
- for people who had moved
- for persons who did not exist

Pursuant to California Elections Code Section 2224, following the November 4, 2014 Statewide General Election, registered voters who have not voted nor had their registrations updated during the last four (4) years will be mailed a postcard notice to confirm their residency. The postcard shall read as follows:

"Important Notice"

"According to our records you have not voted in any election during the past four years, which may indicate that you no longer reside in San Bernardino County. If you continue to reside in this county you must confirm your residency address in order to remain on the active voter list and receive election materials in the mail."

"If confirmation has not been received within 15 days, you may be required to provide proof of your residence address in order to vote at future elections. If you no longer live in San Bernardino County, you must reregister at your new residence address in order to vote in the next election. California residents may obtain a mail registration form by calling the San Bernardino County Elections Office or the Secretary of State's office."
