- 2. Were these unanticipated? Why or why not?
- 3. What were the contributing causes for these issues?
- 4. How relevant was the training for poll workers in your precinct(s)? Did it address the issues you observed? How current was the training?
- 5. Was the precinct compliant with state and federal accessibility requirements?
- 6. What were the most common complaints and/or observations from voters?
- 7. Did you observe any issues with the voting equipment? Were the issues resolved?
- 8. Was the problem escalation policy used in your jurisdiction used? Was it effective?

- 1. From your perspective as a ______, what operational and administrative issues caught your attention in the November election?
- 2. Were these unanticipated? Why or why not?

- 7. The election communities understanding of accessibility issues is evolving. Were there new accessibility issues that were highlighted by the November election?
