
RE: Closure of January 15, 2009 Public Meeting

Pursuant to section 204(a)(4), the EAC is required to appoint a General Counsel for a term of 4 years. The General Counsel's term may then be extended for up to one additional term by vote of the Commission. On January 5, 2009, the EAC certified a vote concerning the appointment of a General Counsel. In that vote, Commissioner Beach objected. Pursuant to the tally vote procedure, the matter must now be discussed at a public meeting. Accordingly, the EAC will hold a public meeting on January 15, 2009, at which it will discuss the appointment of a General Counsel. The Government in the Sunshine Act (5 USC 552b) requires that meetings of the Commission take place in public, subject to several exemptions.

The EAC may close the January 15, 2009 meeting at which it will discuss the appointment of a General Counsel (see certification, attached). As this matter relates to internal personnel rules and disclosure of the EAC's determination would constitute a clearly unwarranted invasion of personal privacy, I recommend closing the portion of the January 15, 2009 meeting at which EAC will discuss the appointment of a General Counsel.
